TUITION AND FEE AGREEMENT Year 2020-2021

NEW STUDENT

For all new students, a onetime **non-refundable** registration fee of \$100 and a \$200 tuition deposit is due at the time of registration. The tuition deposit will be applied against your August tuition payment.

RETURNING STUDENT CONTRACT DUE DATE: JANUARY 16, 2020

For returning students, a January deposit of \$200 will hold your child's placement for the school year 2020-2021. The deposit will be applied against your August tuition payment.

The annual supply fee of \$150 is nonrefundable and is due at the beginning of the school year.

Upon your child's enrollment, you will receive two copies of the Tuition Fee Agreement. One copy must be signed and returned, the other is for your records. The Tuition Agreement outlines the tuition payment schedule (date and amount due). Please note that the tuition is due on the 1st of each month. This is the only payment notice you will get from the school. If any other fees are incurred, a bill will be issued. A late fee of \$20 will be assessed if the tuition is not paid within 10 days of the due date. A cancelled check is your only receipt.

Cancellation policy
