

# TUITION AND FEE AGREEMENT Year 2024-2025

#### **NEW STUDENT**

For all new students, a one-time **non-refundable** registration fee of \$150 and a deposit of one month of tuition is due at the time of registration. The tuition deposit will be applied to your last tuition payment.

#### **RETURNING STUDENT CONTRACT DUE DATE: JANUARY 19, 2024**

For returning students, a non-refundable registration fee of \$50 and a deposit of one month's tuition for the class enrolled will hold your child's placement for the 2024-2025 school year. Your deposit will be applied to your last tuition payment.

The annual supply fee of \$175 is non-refundable and is due at the beginning of the school year. Upon your child's enrollment, please return a signed copy of the Tuition Fee Agreement and keep one copy for your records.

The Tuition Agreement outlines the tuition payment schedule (date and amount due). Please note that the tuition is due on the 1<sup>st</sup> of each month. This is the only payment notice you will get from the school all other notices will be from Brightwheel. If any other fees are incurred, a bill will be issued.

A late fee of \$20 will be assessed if the tuition is <u>not paid within 10 days of the due date.</u> An additional late fee of \$20.00 will be added if not received by the 20<sup>th</sup> of the month. A canceled check is your only receipt.

**Returned Check Fee** of \$25.00 to compensate for bank service charges will be billed and due at the next tuition payment for each returned check for insufficient funds and a late payment fee will be assessed if full payment is not received by the 10<sup>th</sup> of the month. If more than one check is returned for insufficient funds, a cash or bank check-only arrangement may be implemented.

#### **Cancellation policy**

This contract is effective upon acceptance by the school. If your child will not be attending the school in the fall after First Step Preschool has received the deposit, written notice should be given to the school on or before <u>June 1, 2024</u>. If notice is given after that date, <u>the deposit will be forfeited</u>.

If you relocate outside of Fairfield County, you may be entitled to a pro-rated tuition refund, less a \$75 withdrawal fee, provided the following conditions are met: 1) First Step Preschool receives a 30-day written notice, and 2) your child is withdrawn before April 1st.

If your child is accepted into a special education services program, you will be released from your contract and your tuition will be refunded on a pro-rated basis less a \$75 withdrawal fee.

#### Extended Day Program

Our Extended Day program is dependent on enrollment. The Extended Day program is available for our Threes & Fours students every afternoon until 3 pm. This program includes quiet time, free play, and outdoor play This is a wonderful way for children to continue to socialize with other students, in a smaller group, while providing added flexibility to parents and their schedules

Our Extended Day program may be contracted annually or whenever it suits your schedule. Drop-ins are welcome based on availability and must be made 24 hours in advance. Drop-in charges are billed bi-weekly at a rate of \$36/day.
